**Step 2:** Standard TNT delivery to all US locations is by USPS Bulk Mail Rate postage. If you prefer to receive your TNT by USPS First Class Mail (US locations only), enter \$30.00 in the FIRST CLASS MAIL box above.

**Step 3:** If you want to include a donation to the **ABTC Health Fund** and/or make a **Memorial** donation along with your renewal payment, enter the amount(s) in appropriate box(es) above. These donations are NOT tax-deductible.

**ABTC Health Fund:** These donations are used to support a variety of health-related research studies.

**Step 4:** **Include a \$20.00 LATE FEE if your payment will be postmarked after August 1, 2011.** Payments post-marked after August 31, 2011 will be returned unopened, and your membership will automatically lapse.
